Physical records shall be disposed of through shredding, while digital files shall be anonymized.

We advise that no method of electronic transmission or storage is 100% secure, and no one can guarantee absolute data security. We will comply with laws applicable to us in respect of any data breach.

How Long is Your Data Kept

We keep your personal information only for as long as necessary and only for legitimate purpose.
